NEWS FROM THE DOT:

Occasional sale of towable RVs by a motor vehicle dealer

1. A motor vehicle dealer may acquire and sell up to six used towable RVs in a 12-month period, even without a towable RV dealer license. To "sell" in this context includes displaying, advertising or holding in inventory; it does not refer to just final sales.

2. However, if the motor vehicle dealer does not have a towable RV license, then it cannot transact as a dealer for the sale in item **#1**. This means upon acquisition the dealer must take full title to the vehicle, pay relevant registration fees and the vehicle is technically not in dealer inventory. The dealer may not affix dealer plates to the RV and it may not use the dealer reassignment sections on the title. The motor vehicle dealer is selling a used towable RV just as any other business might sell a vehicle in a private sale.

3. If a motor vehicle dealer acquires and sells more than six used towable RVs in a 12-month period, then the dealer must obtain a towable RV dealer license. Any dealer may apply for a towable RV license even if it sells fewer than six used towable RVs.

4. A motor vehicle dealer may not sell a new towable RV unless it has the proper license and franchise agreement.
